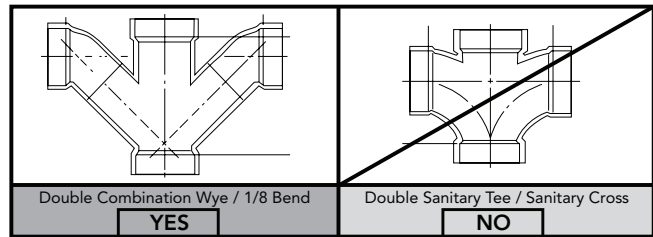

INSTALLATION NOTES

Back-to-Back Toilet Installations:

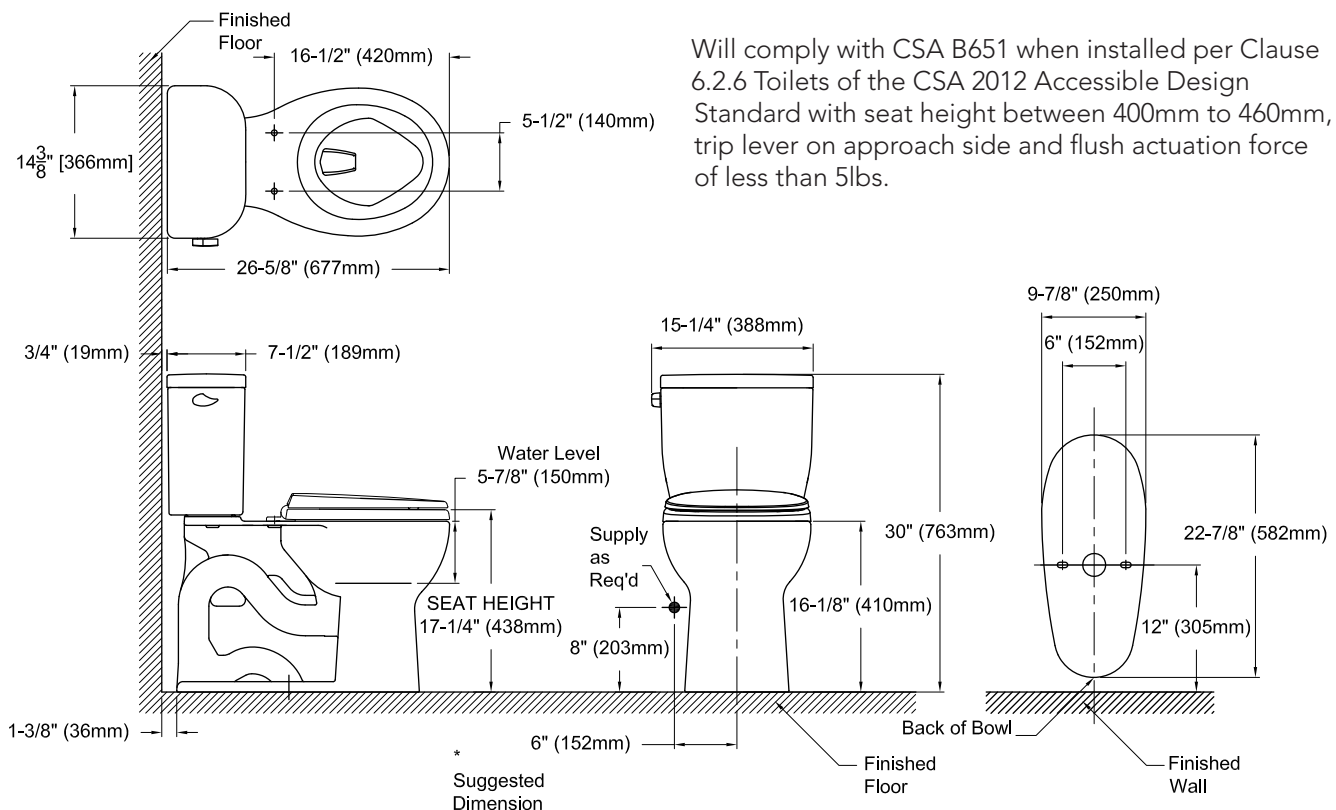
TOTO recommends the use of a nationally listed, double sanitary tee-wye only, in vertical waste stacks, in accordance with the stipulations noted in the majority of nationally recognized plumbing codes.



To maintain adequate wall gap between the back of the tank and wall, mount the floor flange at a nominal 12" rough-in distance.

Will comply with ADA when installed per Section 604 Water Closets and Toilet Compartments of the ADA 2010 Accessible Design Standard with seat height between 17" to 19", trip lever on approach side and flush actuation force of less than 5lbs.

Will comply with CSA B651 when installed per Clause 6.2.6 Toilets of the CSA 2012 Accessible Design Standard with seat height between 400mm to 460mm, trip lever on approach side and flush actuation force of less than 5lbs.
